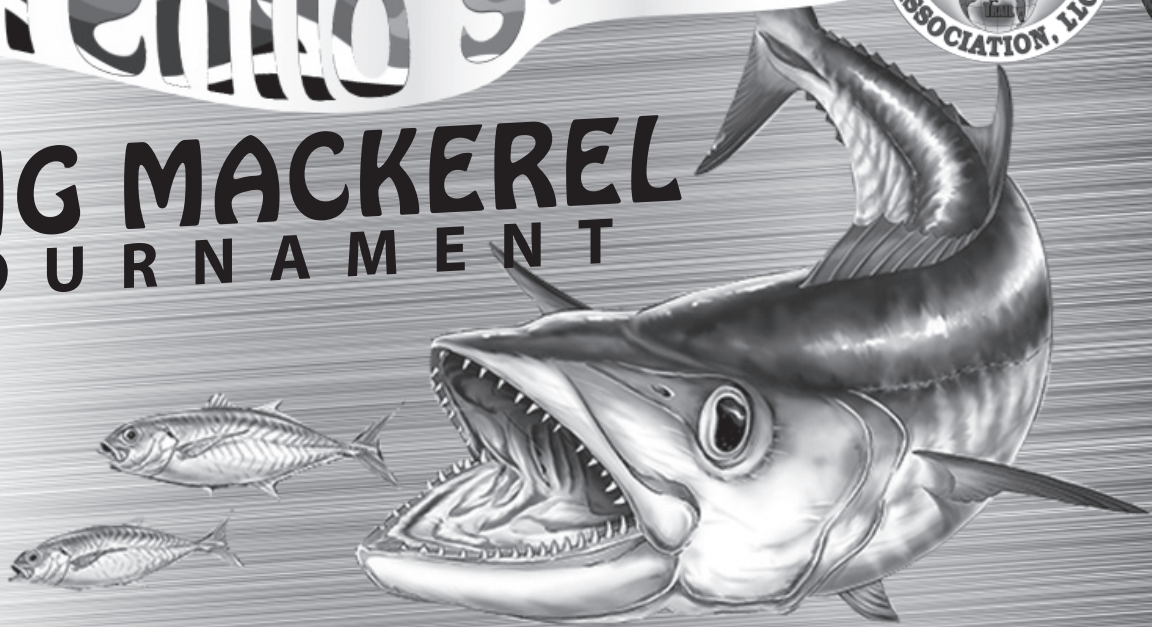

YOU MUST SIGN THE AGREEMENT AS A CONDITION OF ENTRY IN TOURNAMENT  
PARTICIPANTS ARE REQUIRED TO OBTAIN INSURANCE COVERING THEIR AND THEIR VESSEL'S PARTICIPATION

I, INDIVIDUALLY AND AS THE VESSEL'S MASTER(IF, INDEED, I AM THE VESSEL'S MASTER), MY BOAT'S MASTER (IF OTHER THAN BOAT'S OWNER OR OPERATOR), MY TEAM, THE BOAT'S CREW AND GUESTS ABOARD AGREE AND UNDERSTAND THAT THE SOUTHERN KINGFISH ASSOCIATION, LLC., GORENFLO'S BAIT & TACKLE, POINTE CADET MARINA, THE TOURNAMENT SPONSORS, ITS/THEIR DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS (HEREINAFTER REFERRED TO AS "SKA") SHALL NOT BE LIABLE UNDER ANY CIRCUMSTANCES FOR ANY INJURIES OR DAMAGES TO PERSON(S), BE THEY PHYSICAL INJURIES OR OTHERWISE, OR PROPERTY, ARISING OUT OF, RESULTING FROM OR IN ANY WAY CONNECTED WITH my/our crew's participation in any tournament whether caused by or contributed to by any negligent act or negligent omission by the SKA or by any other reason or cause whatsoever. In consideration of the acceptance of me and my team and my crew entry and for other good and valuable consideration received, we hereby remise, release and forever discharge the SKA and its respective heirs, executors, administrators, legal representatives, successors, assigns, parent organization/firm or any firm/organization that the SKA is part of or a division of, its/their directors, officers, employees and agents of and from all claims, suits, obligations, liabilities, losses, damages, costs or expenses which our master, crew, owner(s), operator(s), team or guests aboard or their heirs, executors, administrators, legal representatives, successors, and/or assigns may have against the SKA, arising out of, resulting from, or in any way connected with my/our participation in any tournament. We understand that this release includes any claims based upon any negligent act or negligent omission of the SKA.

To the fullest extent permitted by law, I, individually and as the Vessel's master, the boat's master (if other than the boat's owner or operator), my team and the vessel's crew and guests aboard hereby agree to indemnify, to defend with counsel acceptable to SKA and to hold SKA and its heirs, executors, administrators, legal representatives, successors, assigns, parent firm/organization or any firm/organization that SKA is part of or a division of, its/their directors, officers, employee and agents harmless from and against any and all claims, suits, obligations, liabilities, losses, damages, costs or expenses including but not limited to reasonable attorney fees suffered by SKA or by any other person or persons whatsoever (including any one for whose acts SKA may be liable), regardless of whether it is caused by - or in part by - a party indemnified and held harmless hereunder, arising out of, resulting from, or in any way connected with my/our participation in any tournament.

**Weather**—This is a Captain's Choice Tournament—All boats, owners, operators, masters, crews, guests and anglers will operate their vessels and/or fish at their own discretion and solely at their own risk. One day's fishing will constitute a Tournament.

This agreement shall take effect as an instrument under seal and be binding upon and insure to the benefit of me (individually and as master of the vessel, if indeed I am the master of the boat), by boat's master (if different than the owner or operator of the vessel), my team, the boat's crew and guests aboard, as well as the heirs, executors, administrators, successors and assigns of each.
